Joint Election Agreement between Winnsboro ISD and Hopkins County

JOINT ELECTION AGREEMENT

This agreement is entered into this 18 day of Sept. 2017, by and between Hopkins County, Texas (the "County"), and Winnsboro Independent School District (the "District").

WHEREAS, under Chapter 271 of the Texas Election Code the County and the District have the authority to conduct joint elections; and

WHEREAS, the County and the District will both conduct elections on the November uniform election date, November 7, 2017; and

WHEREAS, the parties to this agreement desire that the respective elections of the entities shall be held jointly for convenience for the voters of the entities.

NOW, THEREFORE, IT IS AGREED that a joint election will be held by the County and the District under the following terms and conditions, and the parties hereto agree with said conditions:

1. That the County and the District will utilize vote centers as designated by the County and the District in their duly adopted resolutions calling their respective elections, and as shown in Exhibit A to this Agreement.
2. That this agreement was adopted by official action of the governing bodies of both the County and the District. That the undersigned are the duly authorized representatives of the parties' governing bodies, and the signatures represent adoption and acceptance of the terms and conditions of this agreement.
