Pending Litigation

The Appraisal District has settled the pending litigation with the Hageman entities in Hopkins County. Those owners have agreed to dismiss their four pending lawsuits filed in 2015 and 2016, in exchange for the District's dismissal of the 2015 lawsuit filed against Steve and Sandra Hageman, L.L.C., and for an agreed judgment providing that the 200-acre parcel leased to a Hageman entity, (Property ID No. R13565) would be valued as open-space land for 2016. The parties have further agreed in writing that the Appraisal District's 2017 values would remain as noticed, with the exception of the leased parcel, which would receive open space value for the current tax year in addition to 2016. All pending lawsuits have been dismissed and orders of dismissal were signed last week, and the agreed judgment on the leased property was also signed by the Court last week.

There will be no refunds owed by any of the affected taxing units except for the refund resulting from the agreement to change the leased parcel to open-space land for 2016. In that agreed judgment, the owner agreed to waive interest on the refund.
