

AMENDMENT TO THE HOPKINS COUNTY PLATTING PROCEDURES AND SUBDIVISION REGULATIONS

On this day, the Hopkins County Commissioners in open court approved an amendment to the Hopkins County Platting Procedures and Subdivision Regulations as follows:

Section 232.0015 EXCEPTIONS TO PLAT REQUIREMENTS

Section 232.0015 (r) An owner of a tract of land located outside the limits of a municipality who divides the tract into two (2) parts is not required to have a plat of the subdivision prepared if:

- (1) all lots in the subdivision are two (2) acres or more in area;
- (2) the owner does not lay out a part of the tract described in Section 232.001(a)(3) of the Local Government Code; and
- (3) each lot has at least 200 feet of frontage on a public road to be used for access only by that tract alone. This provision does not exempt sham transactions staged to avoid the platting requirements.
