

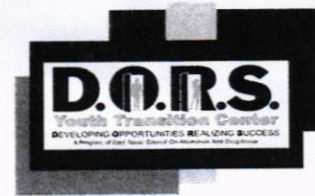

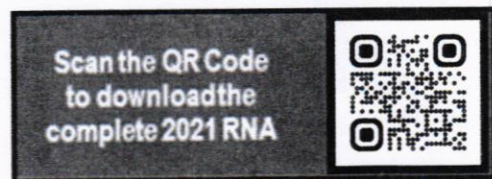
We would also appreciate if you would please sign a non-binding Memorandum of Understanding for FY 2022 (September 1, 2021 – August 31, 2022) by:
