

Order Adopting Redistricting Plan for Commissioners Court Precincts

On the 8th day of November, 2021, the Commissioners Court of Hopkins County met in regular session, having posted notice of said public meeting in compliance with state law.

During an initial assessment, the court evaluated the current commissioner precinct boundaries and determined the legal duty and obligation to redraw the precinct boundaries in order to more appropriately equalize the population distribution between the four commissioner precincts and comply with the "one-person-one-vote" balance following applicable state and federal law.

After convening in Public Hearing to accept comment for the proposed plans, and after meeting in open session to consider available options for modification of the existing precinct boundaries, the Court has determined to adopt the redistricting plan attached to this Order in map and data from as Exhibit 1.

IT IS THEREFORE ORDERED that the Redistricting Plan depicted in the maps and data attached to this Order and hereby Approved and Adopted by the Commissioners Court of Hopkins County, Texas. The Redistricting Plan shall be effective immediately for use in the 2022 Primary and for all subsequent elections until changed or modified by later Order of this Court.

General Description Of The Boundary Change For Hopkins County

Area south of Kyle Street, east of Fisher Street, north of Industrial Drive, and west of Broadway/Gilmer Street (TX Hwy 154) will move from Commissioner Precinct 2 to Commissioner Precinct 1.

Area south of Interstate 30, east of Mockingbird Lane; and Park Springs Road east and west within the census block will move from Commissioner Pct. 1 to Commissioner Pct. 2.

The Pct. 2 line along College Street east of Oak Avenue will move north slightly for the purpose of dividing the Justice of the Peace and Constable offices to allow each to be located in their respective precincts.




