

MATTER OF RECORD

On Tuesday, June 4, 2024, a meeting was held with the developers of the Park Place Mobile Home Park in the ETJ of Cumby, Texas. Present at the meeting were the developers, Cumby Mayor Amber Hardy, Cumby City Secretary Miranda Randle, Commissioner Joe Price, Hopkins County Fire Marshall Andy Endsley, Hopkins County Environmental Officer Kristy Springfield, and Hopkins County Development Coordinator Steve Hudson.

The purpose of the meeting was to inform the developers of the need to install a 20,000 gallon water storage tank for the purpose of supplying water for firefighting operations within their development. Water for the development will be provided by means of a private well owned by the developers which is insufficient for firefighting purposes. While the developers did not say they would not install a water tank, they did indicate they did not intend to do so with their first phase of development.

Hopkins County wishes to make known their opposition to occupation of any structure in this development prior to installation of said water tank.

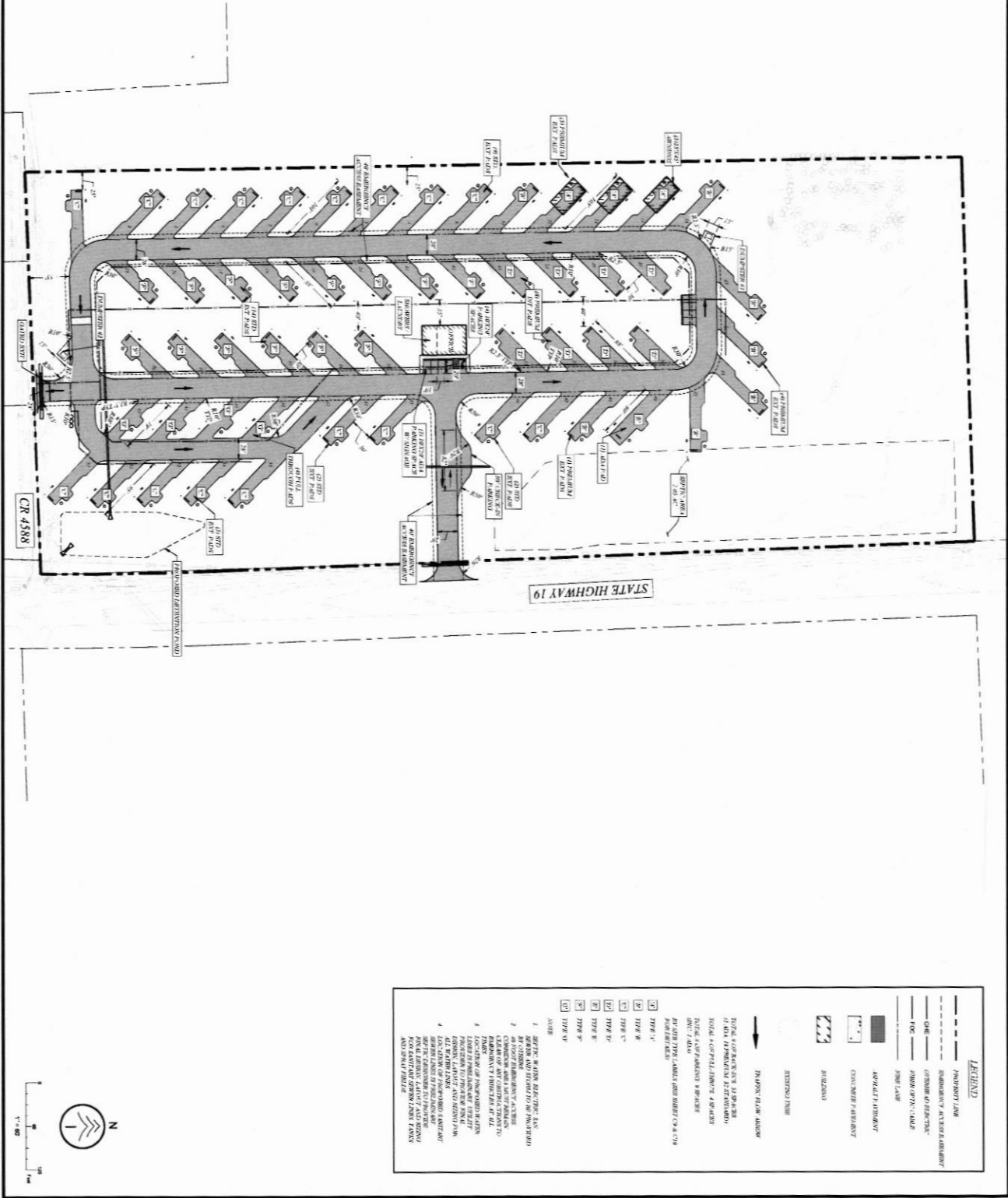

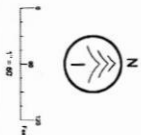
